



## Information for **131st** Paisley Art Institute Annual Exhibition

Please read the schedule carefully

Paisley Art Institute is on the road! During the renovation of Paisley Art Gallery and Museum, PAI will be utilising alternative venues for the Annual Exhibition. This year we will be located in Unit 43A & 54, The Piazza, Central Way, Paisley, PA1 1EL (the old CO-OP premises for anyone who knows it). As well as maintaining the high exhibiting standards that the annual exhibition has long been renowned for, this venue also offers artists the opportunity to consider exhibiting site specific works. This is an exciting opportunity for artists to display work in a non-traditional space with wider public access.

PAI is open to all art forms; final decision resides with the selection panel and hanging committee. **We request that work is not sent by post.**

### Guidelines for wall based work

**Work should be suitably presented for the exhibition, no clip or metal frames and all works framed or unframed should be strong enough to hang. We would ask that you mirror plate your work half way down the frame on the left and right sides (see images), and wrap padding round the mirror plates to protect work during transport and selection.**

**PAI encourages the submission of unframed works however a suitable hanging method must be supplied (eg. large unframed paper works hung using clips)**



### Guidelines for floor based work

The venue used to be a supermarket and many of the fixtures & fittings will still be in place including a cement floor which could be utilised when considering the placement of floor based work. If sculptors wish their work to be displayed on a plinth then they must supply one with their work. Plinths supplied by entrants will not be used with other work without the permission of the entrant.

**ARTISTS SUBMITTING HEAVY OR LARGE ARTWORKS SHOULD ENSURE THAT THEY BRING APPROPRIATE HELP WITH THEM.**

### Labels & data protection forms

All 3 sections of the labels should be completed and attached securely using string to the back of the work so that the label can hang down in front. This should be repeated for each art work. **For additional security and identification, please ensure that the title, plus your name and contact details are written on the back of the work.** Data protection forms must be completed and delivered with your work. Please make sure that handwriting is clear and legible.

### Courier Delivery

As above but include a stamped addressed envelope for the return of slips.

## **Submission & payment**

**Artist Members: membership payments must be up to date prior to submitting work. Please contact the membership secretary; [membership@paisleyartinstitute.com](mailto:membership@paisleyartinstitute.com)**

Artist Members	£20 to submit a maximum of 3 artworks plus an additional 2 small paintings at £2 per painting (£24 max). (a small painting is 16" x 16" or smaller)
Open Entrants	£20 to submit a maximum of 2 art works.
Cash or cheque, made payable to Paisley Art institute (not PAI), must be brought with you at time of submission. <b>Please note that submission fees are non refundable.</b> Paisley Art Institute does not charge a hanging fee.	

## **Size restriction**

The flats (temporary walls) are a maximum height of 8' therefore work should be no taller than 7'. There is no size restriction for sculptural works as long as they can be delivered and accommodated within the exhibition space.

## **Sales & commission**

Artists will be notified of work sold and a commission of 35% will be charged on their work.
